Dr.Sreeja.J, Assistant Professor, Government Dental College, Alappuzha, as per representation 5th read above, has submitted representation stating that, her seniority as per the advice memo has to be restored.

As per the letter 1st read as above, Government have clarified, regarding assigning of seniority, as follows,

The matter has been verified with the records kept in this office and found that, the said matter is already under consideration of the Hon'ble Kerala Administrative Tribunal as per OA(EKM) No.2774/17, filed by Dr.Sreeja.J; Therefore, decision in the representation 5th read above submitted by Dr.Sreeja.J will be taken based on the final verdict of the Hon'ble Kerala Administrative Tribunal in OA (EKM)No.2774/17.

Dr.Sheena .P, Assistant Professor, Government Dental College,

Kottayam, as per representation 6th read above, has submitted representation stating that, as per the direction in G.O.(Rt).No.1797/2018/H&FWD; Dated: 05.06.2018, Government have directed to conduct DPC and to promote her to the rightfully eligible post of Associate Professor and this direction has been overlooked. Therefore, her seniority in the cadre of Associate Professor is to be retained.

The matter has been verified with the records kept in this office and found that, the said order has been challenged by Dr.Eilizabeth Prabha James, as per OA No.1045/2018 and the said matter is under consideration of the Hon'ble Kerala Administrative Tribunal. Therefore, decision in the representation 6th read above submitted by Dr.Sheena .P, will be taken based on the final verdict of the Hon'ble Kerala Administrative Tribunal in OA No.1045/2018.

Dr.Rejula.F, Assistant Professor, Government Dental College, Thiruvananthapuram, as per representation 7th read above, has requested to include her date of joining in the cadre of Assistant professor as 20.10.2006. The matter has been verified with the available records in this office and found correct. Therefore, the date of joining in the cadre of Assistant professor is entered as such.

Dr.Vidya.K.G, Assistant Professor, Government Dental College, Kozhikode, as per representation 8th read above, has submitted representation stating that Dr.Khaleel Ahamed (Sl.no.18 in the Provisional List) who has been placed before her, has availed Leave Without Allowances, before completing his probation, Therefore, her seniority has to be assigned before him.

The matter has been scrutinised with the available records in this office and found that, Dr.Khaleel Ahamed entered in service on 26-12-2018 and he has been granted Leave Without Allowances for 5 years from 25-04-2019, as per order No. G4/876/19/DME dated.22-03-2019, under Appendix XII A of Part I of Kerala Service Rules.

As per the para (5) of Appendix XII A of Part I of Kerala Service Rules, it is clearly stated that.

"In the case of non-permanent officers in regular service who have not completed probation in the entry grade, leave without allowances may be granted subject to the condition that they will have to start afresh and complete their probation on return from the leave without allowances. In other words, the officers will forfeit the service benefits that had accrued to them prior to their proceeding on leave and they will be deemed as new entrants to Government service on return from leave. What is protected is only their right to rejoin Government service in the same entry grade as if they were new entrants."

Dr.Khaleel Ahamed has not completed his period of probation before entering into Leave without Allowances. Therefore, his seniority has to be assigned only with effect from his date of rejoining in service. Now he is continuing in Leave without Allowances. Therefore, the seniority position of Dr.Khaleel Ahamed is hereby corrected as serial number 20 (ie, last in the seniority list). His seniority will be assigned in the suitable position from the date of rejoining in service after Leave without Allowances granted to him under Appendix XII A of Part I of Kerala Service Rules.

The order of declaration of probation of Dr.Subija Narayanankutty and Dr.Mridula Parameswaran, in the cadre of Assistant professor were not entered in the provisional seniority list, which are hereby entered.

No other complaints has been received. In the circumstances, the provisional Seniority

list in the cadre of Assistant Professor in Conservative Dentistry is hereby finalised accordingly; subject to final order of the Hon'ble Kerala Administrative Tribunal in OA (EKM)No.2774/17 and OA No.1045/2018. The final seniority list is appended as Annexure I.
