## ORDER

In the circumstances reported by the Director of Medical Education as per the letter read as  $8^{th}$  paper above, Government hereby orders the following modifications in the General Transfer guidelines issued as per the Government Orders read as  $4^{th}$  to  $7^{th}$  papers above.

- 1. Applicant can submit maximum number of options.
- 2. In order to maintain uniformity in the case of service in the difficult areas among the department under Kerala Government, the period of eligible service in the difficult area under Medical Education Department (Idukki, Manjeri, Konni, Alappuzha and Paripally) will be two years.
- 3. The service under Medical Education Department alone will be considered for general transfer.
- 4. Following details of Home Station will be entered in SPARK

(i) Home Station

(ii) Date of Change of Home Station

(ii) Present Home Station

- 5. The details of Leave Without Allowance/Unauthorised absence/Disciplinary action/Working arrangement and Deputation must be entered in SPARK.
- 6. The applicant who is on Leave Without Allowance for more than six months/Unauthorised absence/Disciplinary action will not be considered for general transfer.
- 7. An opportunity will be given to cancel the previous options submitted in the General Transfer Application and also to submit fresh application in the transfer on monthly basis. The Time schedule shall be published by the Director of Medical Education.
- 2. The Government Orders read as  $4^{th}$  to  $7^{th}$  papers above stands modified to the above extent.
