Notification

The final round (**spot**) allotment process of PG Super Specialty (DM/M.Ch) Courses 2016 for General merit candidates is scheduled to be held on **30.08.2016** was notified in the website of DME vide this office notification of even number dated 25/08/2016.

All qualified candidates are free to attend the counseling except

- 1) Those candidates who have received the admission memo and not joined the course.
- 2) Those candidates who have discontinued the course after joining.

All the General merit candidates as detailed below are required to attend the counseling.

Those candidates, who have taken admission in the self Financing Colleges, if they wish to participate in the final (spot) round counseling, shall produce the NOC from the college concerned at the time of counseling to the effect that the candidate can participate in the spot admission, surrender their seats for higher option and will admit candidates to the surrendered seats from Government merit list.

The spot admission will be conducted in strict accordance as stipulated in Clause 12.2.6 of the PGSS prospectus-2016.

Candidates who desire to attend the counseling will have to download the prescribed format of preference form from the website "www.dme.kerala.gov.in". If a candidate is not able to attend the allotment process, the parent/guardian or any authorised person can act as proxy at the risk of the candidate. Such authorised person should produce an authorisation letter in the prescribed format which can be downloaded from the website. Candidates have to produce the admit card of the entrance examination and the certificates as mentioned in the Prospectus. Candidates who do not submit either original or provisional certificate to prove their PG Degree qualification at the time of counseling will not be considered for the allotment.

Candidates who have taken admission in the previous round counseling should produce the possession certificate from the respective college.

The candidates are advised to have a close watch on the website of DME for further information in the matter, if any.
